Children enter foster care when they have been removed from their parents or guardians and placed under the responsibility of a child welfare agency. Reasons for a child's removal can vary, though the vast majority of nearly 275,000 removals during fiscal year 2016 involved issues of neglect and substance abuse by the parent. What happens next can unfold in many different ways—children may be placed with relatives, with unrelated foster parents, or in congregate care settings until they are reunified with their parents, are adopted, or "age out" of the system. Courts, social workers, and policymakers have been involved in decisions about when to remove a child and whether reunification is possible. However, the voices of those directly affected oftentimes get lost. Please join the At-Risk Youth Community of Practice as we listen to and learn from former foster youth and parents affected by the child welfare system.

1. *Introduce yourself, your lived experience within the child welfare system; consider adding how are you advocating or working in child welfare now.*

2. *Based on your experiences: if removal of a child from their parent is necessary, what is necessary to reduce harm and trauma?*
 - keeping siblings together
 - placement with relative/fictive kin
 - school stability
 - normalcy
 - visits between parent and child and making them as normal as possible
 - foster-bio parent relationships

3. *What kind of supports and services helped strengthen your family? Was there anything that could have been helpful that wasn't offered to you and your family?*
 - a. *For Edwin - are there things you have found that work especially well with dads? We know that parents need different kinds of support at different times - what kind of supports have helped you and your family a you care for your niece and nephew? (if he's able to talk about the supports after his niece and nephew started living with him - it may be helpful for the audience to get a better sense about the need for post-permanency supports)*
 - b. *For Eric - can you talk about what the congregate care placement for you was like and what you wished was different?*
 - c. *For Joe, what supports could have benefited your grandparents in caring for you?*

4. *What is one takeaway you hope the audience leaves with as they think about policies and practices that will keep children safe and strengthen families?*
